John, I have no idea which case you are referring to.

I have reviewed your letter and email requests with the FBI. I am perplexed that you and Mr. Negley apparently believe that there is an active case in which Mr. Negley could be subpoenaed to provide testimony, based on a vague note contained on a fax cover sheet from 11 years ago. There is no pending FBI investigation regarding Mr. Negley. We believe the note you reference from 11 years ago relates to the size of the Unabomber investigation as a whole, not any investigation of Mr. Negley. Mr. Negley has received the only investigative records of which we are aware.
